AGREEMENT TERMS AND CONDITIONS

THE TERMS AND CONDITIONS, together with the related credit application (collectively, the "Agreement") govern the establishment and use of a charge card account provided by WILKINSON DEVELOPMENT, INC. ("Creditor"), to the account holder identified in the credit application approved by Creditor ("Customer").

The Customer may use this card to make purchases at any Fat Dogs locations in Nebraska and Time Saver locations in North Platte, NE and additional sites acquired by Wilkinson Companies if applicable.

1. Purchases of lottery tickets or other games of chance, gift cards, pre-paid cards or other cash equivalent charges are prohibited.
2. Customer shall designate Card Holders as well as those contacts authorized to:
 - a. provide Issuer with the information necessary to establish and maintain account and cards;
 - b. provide vehicle, driver and other information;
 - c. receive all account numbers, cards or reports;
 - d. receive other account information; and
 - e. select additional products and/or services that may be offered.
3. Customer will provide notice of any change or removal of any contact or Card Holder either in emailing getfuel@wilkco.com, by telephoning 308-532-3090 ext. 203, or online at www.cards.intevacon.com. Customer shall ensure that each Card Holder complies with the terms and conditions of this Agreement. Customer is liable for any misuse of cards.
4. Customer assumes all risk if Customer chooses to leave a card at an accepting location for use by its drivers or Card Holders and, as such, agrees to pay for all charges made with that card or on that account.
5. Customer agrees to keep PINs confidential and ensure that its Card Holders do not disclose any PIN. Customer is liable for any Unauthorized Use that results if a Card Holder discloses a PIN.
6. Creditor will notify Customer of the Credit Limit assigned to the account. Customer shall ensure that the balance of the Account does not exceed the assigned Credit Limit. Creditor may change the Credit Limit in its sole discretion without prior notice, except as may be required by applicable law. Creditor may, but is not required to, permit Customer to exceed its Credit Limit.
7. Creditor may suspend an account or refuse to authorize any transaction in its sole discretion for any reason, including if: (a) any balance is past due; or (b) the amount of the transaction plus the outstanding balance (including transactions authorized but not yet posted) exceeds the Credit Limit.
8. Creditor will provide Customer with a billing statement for each Billing Cycle in which the account has activity. Customer agrees to pay Creditor in full, on or before the due date, as shown on the statement. Any overdue balance that exceeds 30 days or more shall accrue interest charges at Nebraska's maximum APR rate.
9. Creditor may offer discounts to Card Holders. Such discounts may be suspended, modified, or discontinued at any time without prior notice and may not be applicable to all fuel types. In addition, certain conditions to earn or receive the discount, such as but not limited to, maintaining the Customer's account in good standing, will apply and be provided to Customer when such offers are made.
10. The applicant represents that the information given in this application is complete and accurate and authorizes Creditor to check with credit reporting agencies, credit references and other sources disclosed to confirm information given. Use of any card issued pursuant to this application confirms Applicant's agreement to said terms and conditions.
